

**Corff Llywodraethol YSGOL GRh yr EGLWYS
YNG NGHYMRU St FLORENCE, St Florence,

Rhybuddir yn unol ag adran 42 Deddf Safonau a Threfniadaeth Ysgolion Cymru (2013) a'r Cod Trefniadaeth Ysgolion (Gorffennaf 2013) bod Corff Llywodraethol Ysgol GRh yr Eglwys yng Nghymru St Florence, fel y cynigedd, ar ôl ymgynghori â'r personau angenheidiol, yn bwriadu gweithredu newid rheoledig i Ysgol GRh yr Eglwys yng Nghymru St Florence, St Florence, Dinbych y Pysgod, SA70 8LY trwy weithredu'r newidiad canlynol:

Newid ystod oedran y disgylion y gellir eu derbyn o 4-11 blwydd i 3-11 blwydd er mwyn galluogi derbyn disgylion meithrin.

Mae'n fwriad i weithredu'r cynnig ar 1af Fedi 2018.

Caiff y cynnig i newid ystod oedran Ysgol GRh yr Eglwys yng Nghymru St Florence ei weithredu gan Gyngor Sir Penfro, sef yr awdurdod sy'n cynnal yr ysgol yn bresennol ac yn y dyfodol. Ni fydd newid i gapasiti'r ysgol wedi gweithredu'r cynnig, sef 95 o lefydd. Yn ogystal, caiff 10 o lefydd cyfatebol a llawn amser meithrin eu creu trwy weithredu'r cynnig. Ar ddyddiad y censws yn Ionawr 2018, roedd 56 o blant ar rôl yr ysgol. Y Rhif Derby ar gyfer pob grŵp blwyddyn perthnasol yr ysgol newydd yn ystod y flwyddyn ysgol gyntaf pan fydd y cynigion yn cael eu gweithredu fydd 13.

Ar ran y cynigedd, ymgymerodd Cyngor Sir Penfro â chyfnod o ymgynghori cyn penderfynu cyhoeddi'r cynnig hwn. Mae Adroddiad Ymgynghori sy'n cynnwys crynodeb o'r materion a godwyd gan y rhai yr ymgynghorwyd â hwy, ymatebion y cynigedd a barn Estyn wedi ei ystyried gan Gorff Lywodraethol Ysgol GRh yr Eglwys yng Nghymru St Florence ac mae ar gael yn yr ysgol ac ar wefan y Cyngor (www.pembrokeshire.gov.uk).

Bydd Cludiant o'r Cartref i'r Ysgol yn cael ei ddarparu yn unol â Pholisi Cludiant o'r Cartref i'r Ysgol yr awdurdod o ddyddiad gweithredu'r cynnig, h.y. i ddisgylion sydd wedi cyrraedd yr oedran ysgol statudol.

O fewn cyfnod o 28 diwrnod wedi cyhoeddi'r cynigion hyn, hynny yw erbyn 28ain Mawrth 2018, gall unrhyw berson fynegi gwrrhwynebiad i'r cynigion. **The Governing Body of St FLORENCE CHURCH

Notice is given in accordance with section 42 of the School Standards and Organisation (Wales) Act 2013 and the School Organisation Code (July 2013) that the governing body of St Florence Church in Wales VC School, as the proposer, having consulted such persons as required, proposes to make a regulated alteration to St Florence Church in Wales VC School, St Florence, Tenby, SA70 8LY to implement the following alteration:

That the age range of the pupils it can admit is amended from 4-11 years to 3-11 years in order to effect the admission of nursery pupils.

It is proposed to implement the proposal on 1st September 2018.

The proposal to alter the age range of St Florence Church in Wales VC School shall be implemented by Pembrokeshire County Council, the current and proposed maintaining authority. The proposal involves no change in the capacity of the school, this being 95 places. In addition, the effect of the proposal is to add 10 fte nursery places. At the date of the census in January 2018, there were 56 pupils on roll at the school. The Admission Number for the school for the relevant age group in the first year in which the proposals have been implemented will be 13.

On behalf of the proposer, Pembrokeshire County Council undertook a period of consultation before deciding to publish this proposal. A Consultation Report containing a summary of the issues raised by consultees, the proposer's responses and the views of Estyn was considered by the governing body of St Florence Church in Wales VC School and is available at the school and on the Council's website (www.pembrokeshire.gov.uk).

Home to School Transport will be provided in accordance with the Authority's Home to School Transport Policy as at the date of the implementation of the proposal, i.e. to pupils who have reached statutory school age.

Within a period of 28 days after the date of publication of these proposals, that is to say by 28th March 2018, any person may object to the proposals.
