The Order will further amend the "Pembrokeshire County Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Consolidation) Order 2011 and schedules contained therein and subsequent variations.

The effect of the proposals will be to introduce new, amend and/or revoke existing waiting restrictions on those lengths of road listed in the Schedule to this notice.

1 Haverfordwest

1.1 No waiting at any time

Furzy Park

North side – from a point 20 metres west of the centre of Snowdrop Lane west for 20 metres

Haverfordwest High School Access Road

North Side – from a point 20 metres west of the junction of A40 Scotchwell Roundabout to Cardigan road roundabout, west for 233 metres.

South side – from a point 20 metres west of the junction of A40 Scotchwell Roundabout to Cardigan road roundabout, west for 216 metres.

2.1 No waiting at any time

Hall Court

South side – from its junction with Church Road east for 20 metres.

3. Milton

3.1 No waiting at any time

C3030 Milton to Cosheston road

The Pembrokeshire County Council ('the Council') in exercise of its powers under Sections 1, 2, 4, 32, 35, 45, 46,49, 53, 101, 102, 124 and part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") as amended, the provisions of the Traffic Management Act 2004 ("the 2004 Act") and of all other enabling powers of the Act, and after consulting the Chief Officer of Police in accordance with Part IV of Schedule 9 to the 1984 Act hereby make the following Order:-

- This Order shall come into operation on the ... day of 2024 and may be cited as the Pembrokeshire County Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Consolidation) Order 2011 (Variation No. 28) Order 2024.
- The Pembrokeshire County Council (Prohibition and Restriction of Waiting, Loading and Parking Places) Consolidation Order 2011 ("the Consolidation Order") including the schedules contained therein and subsequent variations are hereby varied or amended as follows:-

1) Amendment of Schedule 1

In Schedule 1.1, insert:-

South Parade, Five Arches, Tenby

East side – from the parking bay on the northern side of the Five Arches around the radius to the start of the bay on the southern side of the Five Arches.

The Croft, Tenby

West side – from the junction with the Norton, northwards for 30 metres.

2) Amendment of Schedule 2

(a) In Schedule 2.1, insert:-

Haverfordwest

Furzy Park

North side – from a point 20 metres west of the centre of Snowdrop Lane west for 20 metres.

Haverfordwest High School Access Road

North side – from a point 20 metres west of the junction of the A40(T) Scotchwell Roundabout to Cardigan road roundabout, west for 233 metres

South side – from a point 20 metres west of the junction of A40(T) Scotchwell Roundabout to Cardigan road roundabout, west for 216 metres

Johnston

Hall Court

South side- from its junction with Church Road east for 20 metres

Milton

C3030 Milton to Cosheston road

East side – from its junction with the A477(T) northwards for 46 metres

West Side - from its junction with the A477(T) northwards for 35 metres

C3030 Loop road

South side - From its junction with the C3030 Milton to Cosheston road, westwards for 15 metres

(b) Schedule 2.1 of the Order is amended as follows:-

Tenby

The Croft, for paragraph relating to west side (a), is deleted

For paragraph (b), substitute:

West side - from a point 30 metres north of the junction with the Norton north and east to the boundary of the properties Seafield/Carmen.

(c) In Schedule 2.2, insert:-

St Davids

The Pebbles

South side - from a point 48 metres west of Cross Square westwards for 60 metres

(d) Schedule 2.11 of the Order is amended as follows:

St Davids , for paragraph relating to west side c), substitute:

Nun Street

West side – c) from a point 7 metres north of the south boundary of no. 77 northwards for 14 metres

(e) In Schedule 2.11, insert:-

St Davids

Nun Street

West side – d) from the south boundary of no. 85 Nun Street northwards for 146 metres.

6) <u>Revocations</u>

Those lengths of road contained in "the Consolidation Order" including the schedules therein and subsequent variations are hereby revoked where specifically mentioned or where the amendment as contained in this Order provides a new definition of the restriction to apply to that section of highway.

Statement of Reason

The proposals to introduce or amend on street parking restrictions as contained in the draft Order attached are being promoted as part of the Councils continual review of on street parking provision on the County road network.

The proposals aim to ensure that existing restrictions are appropriate for a location, and that matters identified through public and community representation are considered and implemented where justified. The amended restrictions also reflect changes to the highway and ensure the safe movement of pedestrian and vehicular traffic.
