

**THE PEMBROKESHIRE COUNTY COUNCIL
(OFF-STREET PARKING PLACES) (CONSOLIDATION) ORDER 2011
(VARIATION ORDER NO. 9 2019)**

NOTICE is hereby given that Pembrokeshire County Council proposes to make an Order under Sections 32 and 35 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the 1984 Act") as amended and the provisions of the Traffic Management Act 2004 and all other enabling powers.

The effect of the order will be to vary The Schedule ("the Schedule") to the Pembrokeshire County Council (Off-Street Parking Places) (Consolidation) Order 2011

1. To introduce Electric Vehicle (EV) charging points in all Pembrokeshire County Council car parks, as listed in all Off-Street Parking Places Orders, for use with Electric Vehicles.
2. To change the name of car parking place numbered 26 in Column 2 of the Schedule, 'Riverside Market' to 'Glan-yr-Afon'
3. To amend the plan of car parking places numbered 71.
4. To introduce a new car park in Column 2 of the Schedule at car park place numbered 5A
