**NOTICE** is hereby given that Pembrokeshire County Council propose to make an Order in exercise of its powers under Sections 1,2,4,32,35,45,46,49,53,101,102,124 and part IV of Schedule 9 to the Road Traffic Regulation Act 1984 (“the Act) as amended, the provisions of the Traffic Management Act 2004 (“the 2004 Act”), and of all other enabling powers.

The Order will further amend the “Pembrokeshire County Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Consolidation) Order 2011 and schedules contained therein and subsequent variations.

The effect of the proposals will be to introduce new, amend and/or revoke existing waiting restrictions on those lengths of road listed in the Schedule to this notice.

**1 Haverfordwest**

**1.1 Removal of No waiting at any time**

**Barn Street**

North west side - from a point 84 metres north eastwards of the junction with Spring Gardens Lane north east for 16 metres

## **1.2 Limited Waiting bay 30 minutes, no return within 30 minutes**

### **Barn Street**

North west side - From a point 84 metres north eastwards of the junction with Spring Gardens Lane north east for 16 metres

## **1.3 Removal of Goods Vehicles loading bay 30 minutes, Monday-Saturday 8am-6pm**

### **Upper Market Street**

East Side – From a point 24 metres south of the centre of Goat Street, south for 10 metres

## **1.4 Removal of Limited waiting bay 1 hr no return 1 hour, Monday-Sat 8am-6pm**

### **Upper Market Street**

East side – From a point 12 metres south of the centre of Goat Street, south for 12 metres.

## **2. Milford Haven**

### **2.1 Limited waiting bay 30 minutes no return within 30 minutes**

#### **Richard John Road**

North side - From a point 6 metres east of the east gable of No. 6 Marble Hall Chip Shop, west for 10 metres for the four spaces set at right angles to the frontage of the building

## **3. Saundersfoot**

### **3.1 No loading at any time**

#### **Milford Street**

North side – from a point 27 metres west of the centreline of Cambrian Place westwards for a length of 50 metres

### **3.2 No waiting at any time**

#### **The Strand**

West side – from a point 25 metres north of the south boundary of Pharmacy Court to a point 5 metres north of the north boundary of Smugglers Cottage (replaces seasonal restriction with all year round restriction)

#### **4. Tenby**

##### **4.1 No waiting 8pm – 7am Caravan or Motor caravan**

###### **The Croft**

East side- from a point 82 metres north of the junction of The Norton, north to a point 16 metres south of the boundary of Harbour Heights and Richmond House.

##### **4.2 No waiting at any time**

###### **Southlands**

North, East & south side – From a point 3 metres south west of the north gable end of no. 4 Southlands around the turning area to the boundary of no. 8/9 Southlands.

###### **Upper Hill Park**

East side- from its junction with the estate loop road, south for 10 metres


**Statement of Reason**

The proposals to introduce or amend on street parking restrictions as contained in the draft Order attached are being promoted as part of the Councils continual review of on street parking provision on the County road network.

The proposals aim to ensure that existing restrictions are appropriate for a location, and that matters identified through public and community representation are considered and implemented where justified. The amended restrictions also reflect changes to the highway and ensure the safe movement of pedestrian and vehicular traffic.





The Pembrokeshire County Council ('the Council') in exercise of its powers under Sections 1, 2, 4, 32, 35, 45, 46,49, 53, 101, 102, 124 and part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") as amended, the provisions of the Traffic Management Act 2004 ("the 2004 Act") and of all other enabling powers of the Act, and after consulting the Chief Officer of Police in accordance with Part IV of Schedule 9 to the 1984 Act hereby make the following Order:-

1. This Order shall come into operation on the .....day of ..... 2022 and may be cited as the Pembrokeshire County Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Consolidation) Order 2011 (Variation No. 24) Order 2022.
2. The Pembrokeshire County Council (Prohibition and Restriction of Waiting, Loading and Parking Places) Consolidation Order 2011 ("the Consolidation Order") including the schedules contained therein and subsequent variations are hereby varied or amended as follows:-

**1) Amendment of Schedule 1**

**In schedule 1.1, insert**

**Saundersfoot**

Milford Street

North side – from a point 27 metres west of the centreline of Cambrian Place, westwards for a length of 50 metres.

**2) Amendment of Schedule 2**

**(a) In Schedule 2.1, insert:-**

**Haverfordwest**

**Barn Street**

North west side – from a point 102 metres south west of the junction with Spring Gardens Lane, north eastwards to its junction with City Road

## **Saundersfoot**

### **The Strand**

West side – from a point 25 metres north of the south boundary of Pharmacy Court to a point 5 metres north of the boundary of Smugglers Cottage

## **Tenby**

### **Southlands**

North, East and south sides – from a point 3 metres south west of the north gable end of no. 4 Southlands around the turning area to the boundary of no. 8/9 southlands

### **Upper Hill Park**

East side – from its junction with the estate loop road, south for 10 metres.

## **(b) In Schedule 2.1 of the Order is amended as follows:-**

### **Haverfordwest**

#### **Barn Street, for paragraph relating to north west side (c), substitute:**

c) from a point 11 metres south west of its junction with Spring Gardens Lane north eastwards for 85 metres.

## **(c) In schedule 2.8 of the Order is amended as follows:-**

a) The entry relating to Milford Street, north side Saundersfoot is withdrawn.

b) The entry relating to The Strand, Saundersfoot – west side (c) is withdrawn

## **(d) In Schedule 2.18 of the Order, insert:-**

### **Tenby**

#### **The Croft**

East side – from a point 82 metres north of the junction of The Norton, north to a point 16 metres south of the boundary of Harbour Heights and Richmond House

## **Amendment of Schedule 3**

### **In schedule 3.3 of the Order, insert:-**

#### **Haverfordwest**

#### **Barn Street**

North west side – from a point 86 metres south west of the junction with Spring Gardens Lane, north eastwards for a distance of 16 metres

**Milford Haven**

**Richard John Road**

North side – From a point 6 metres east of the east side of No. 6 Marble Hall Chip Shop, west for 10 metres for the four spaces set at right angles to the frontage of the building

**In schedule 3.11 of the Order is amended as follows:-**

The item relating to Upper Market Street, Haverfordwest – east side (a) is withdrawn

**Amendment of Schedule 5**

**In schedule 5.10 of the Order is amended as follows:-**

The item relating to Upper Market Street, Haverfordwest – east side is withdrawn

**3) Revocations**

Those lengths of road contained in “the Consolidation Order” including the schedules therein and subsequent variations are hereby revoked where specifically mentioned or where the amendment as contained in this Order provides a new definition of the restriction to apply to that section of highway.
