Statement of Reasons:

**SCHEDULE 1
30 MPH SPEED LIMIT**

1.01.0	B4341 BROADWAY
	The proposals are being advanced in conjunction with footway construction, traffic calming measures, and a speed limit review for these roads. The review considered the collision history, speed survey data, new road geometry, and increased residential development. It concluded that the current speed limit should be reduced to 30mph.

**SCHEDULE 2
40 MPH SPEED LIMIT**

2.01.0	B4314 GUMFRESTON TO SAGESTON
	A speed limit review has been conducted on this section of road. The review considered the collision history, speed survey data, geometry of the road, and other factors including junctions and vehicle laybys. The review concluded that the current limit should be reduced to 40mph in order to ensure safe operation of all turning movements from multiple accesses, junctions and through traffic.

2.02.0	A478 CRANE CROSS
	<p>A speed limit review has been conducted on this section of road.</p> <p>The review considered the collision history, speed survey data, traffic volumes, vehicle classification, road geometry, and other factors including junctions and local amenities. The review concluded that the current limit should be reduced from 50mph to 40mph to maintain a safe and consistent speed distribution along this length of the A478 and ensure the safety of all turning movements from the accesses, junctions and through traffic.</p>

2.03.0	B4314 NARBERTH - COX HILL
	A speed limit review has been conducted for this section of road. It proposes extending the existing 40mph limit up to the 30mph zone at Robeston Wathen Roundabout. The review determined that, due to the road's geometry, localized narrowing, and multiple accesses with poor visibility, the current National Speed Limit should be reduced to 40mph.

2.04.0	A4075 NASH FINGERPOST
	This proposal confirms the signed 40mph limit introduced as part of the Nash Fingerpost improvements and installation of Traffic Signals undertaken by the South Wales Trunk Road Agents.

2.05.0	A487 PANTEG
	<p>A speed limit review has been conducted on this section of road following representation from residents. Panteg forms a linear settlement with a number accesses, minor junctions and amenities. The review considered the collision history, speed survey data, traffic volumes, vehicle classification, road geometry, and other factors including junctions and local amenities.</p> <p>The review concluded that the current limit should be reduced to 40mph to maintain a safe and consistent speed distribution along this length of the A487.</p>

2.06.0	B4329 POYSTON CROSS
	A speed limit review has been conducted for this section of road. It proposes extending the existing 40mph limit from Crundale to beyond the extents of Poyston Cross. The review determined that, due to the road's geometry, localized narrowing, and multiple accesses with poor visibility, the current National Speed Limit should be reduced to 40mph.

	<p>A speed limit review has been conducted on this section of road.</p> <p>The review considered the collision history, speed survey data, traffic volumes, vehicle classification, road geometry, and other factors including junctions and local amenities.</p> <p>The review concluded that the current limit should be reduced from 50mph to 40mph to maintain a safe and consistent speed distribution along this length of the A487 and ensure the safety of all turning movements from the accesses, junctions and through traffic.</p>
