This can be achieved by opening the site entrance from the Llanfallteg road. To slow traffic at the Crossroads a mini roundabout should be introduced. 2. The access from Phase 2 into Phase 3

should be kept to pedestrian access and closed to vehicles. 3. There 7 remaining plots to be developed in Phase 2 and these will be more than enough for residents to cope with. 4. In line with the Wellbeing of Future Generations Act, the number of dwellings proposed should be reduced, until a detailed plan of the site is received. There should be more space in
