Re: HSG/152/LDP2/1 site ref: 340 south of Bro'r Dderwen, Clunderwen, SA66 7NR

I have heard through word of mouth that the Council is planning to develop the land behind my home in Bro'r Dderwen. This is something that I strongly object to.

My biggest concern is the safety of the road into and through the current development. It is a narrow road turning in directly off the fast-moving A478, where cars ignore the speed restrictions until much further into the village. The entrance is made worse by the homes in the terraces on either side having only one parking space. The road and pavements are often blocked by second or third cars belonging to these homes. It is already dangerous for me (I am an OAP) and my almost blind neighbour to negotiate the pavements and crossing this road. There are friends that we both visit in the village and the added traffic from a further (up to) 62 houses and the construction vehicles in the meantime, will make it nigh on impossible to negotiate. Are we to stop being involved in village life? It would be much better if the Council found a different way of entering the development or consider siting the said development at another location within the village boundary for example Gower Villa Lane or Golwg Yr Eglwys.

I am very concerned about the impact any proposed new houses will have on the light in my home. The back of my home is south-facing and I have enjoyed 22 years of direct and uninterrupted light through my windows. I believe that after 20 years I have acquired the right to that full light by prescription – see Section 3 of the Prescription Act 1832 and the Rights of Ligh Act 1959.

Further development of Bro'r Dderwen will cause more noise, more disturbance and nuisance. I have witnessed construction work and traffic for the entire 22 years that I have lived here. The development is inappropriate for the rural nature of Clunderwen. Village life will be negatively impacted and the

Welsh language along with it. As a first language Welsh speaker I feel very strongly about this.

As an OAP I spend a lot of time looking out at and enjoying my garden. If the land south and east of my home were to be developed, the natural habitats of the wildlife will be lost. Can the Council guarantee that my garden will still be visited by the scores of different birds and other wildlife, if there are homes built directly to the south and east of mine?

I look forward to receiving a response to my queries.
