Registered childcare

Schools are encouraged to be mindful of the rental charges made to organisations running registered childcare provision. Whilst there is no expectation for groups to be subsidised by schools, rental charges should be kept to a minimum on the understanding that wrap-around childcare is beneficial to current and prospective parents of pupils of the school. Due to the flexibility offered by some schools, registered childcare organisations are able to provide holiday provision in addition to the normal after school provision. As a result, it is not feasible to recommend a scale of charges for registered childcare at this stage.
