Future Primary Education Provision in the Milford Haven Area

I write to inform you that Pembrokeshire County Council, at its meeting of 20th July 2017, considered the following published proposal:

1. Discontinue The Meads Infant and Nursery School and Milford Haven Junior School on 31st August 2018;
2. Establish a new 3-11 community primary school for Milford Haven on 1st September 2018 utilising both existing school sites.

The decision of Council was to approve the proposal as published.

Prior to reaching its decision, the County Council took account of the comments received as part of statutory consultation, and the proposer's responses thereon. Furthermore the Council were satisfied that the proposal will address the key issues identified in the case for change, i.e.:

- To improve standards;
- To create an all-through 3-11 community primary school in Milford Haven. The Council has a policy of creating all-through schools instead of separate infant and junior schools;
- To provide additional capacity in order to meet the growing demand for places in Milford Haven.

No objections were received.

A temporary governing body for the new school will be appointed in due course so that the appropriate implementation arrangements can be made.
