

Section 1: The proposal:

# Describe the outcome to be achieved, the output that will contribute to this and what you propose to change to facilitate this.

The Welsh Language (Measures) 2011 sets out a legal framework which imposes a duty on Pembrokeshire County Council to comply with the Standards relating to the Welsh Language. Pembrokeshire County Council has a legislative requirement under Standard 145 of the Welsh Language Standards 2015 to publish a 5 year strategy that sets out how it proposes to promote the Welsh Language and to facilitate the use of the Welsh Language widely in Pembrokeshire.

The 5 year strategy has been specifically produced to positively promote the use of Welsh in the Community; workplace and in Education. It will be used to influence and encourage the use of the Welsh Language and to promote the Welsh culture and heritage.

We aim to continue to meet the corporate initiatives introduced in order to comply with the Welsh Language standards and to meet the objectives of the Welsh in Education Strategic Plan and More than Just Words by influencing and encouraging the use of the Welsh Language and to promote the Welsh culture and heritage.

## Section 2: Fit to the well-being goals:

A prosperous Pembrokeshire/Wales (the economy, education and skills)

Our strategy will promote Welsh medium education in accordance with the Welsh in Education Strategic Plan

The draft of the WESP 2017-2020 went out to consultation in November 2016 with a closing date of 9/12/16.)

#### Collaboration

Collaboration through the Welsh Language Standards Development Group which consists of at least one representative from each Council Directorate. The work being carried out will contribute positively to the Well-being of Future Generations Act where the Welsh Language is one of the well-being aims. The key guidance provided within More Than Just Words (The Welsh Government strategic framework for Welsh Language services in Health and Social Services) is responded to positively within our Welsh Language development.

Standard 146 of the Welsh Language Standards requires that this Council five years after publishing a strategy in accordance with Standard 145 assess to what extent the Council has followed that strategy.
