We may share data with Defra and its agencies, Welsh Government, Scottish Government, Food Standards Agency, Public Health, and other organisations and enforcement authorities. We will also make any disclosures required by law and we may also share this information with other bodies responsible for detecting/preventing fraud or auditing/administering public funds to ensure money is targeted and spent in the most appropriate and cost effective way. In order to achieve this, information may be shared with other internal departments within Pembrokeshire County Council and with The Auditor General for Wales.

We will not make any disclosures to third parties for marketing purposes.

Your data will be secure and confidential at all times and we will only collect the personal information that is required.

Names and addresses of all licenced animal establishments in Pembrokeshire will be published on the PCC website.

3. How long do we keep hold of your information?

We will retain the information provided to us for (see specific retention document for the team) and your information will be securely disposed of once it is no longer required.

- The right to not be subject to automated decision-making and profiling
