Fair Processing Notice – Building Maintenance

1. Why do we collect and keep your personal information?

We collect and use your personal information so that we can respond to requests for, arrange and carry out repairs and maintenance to Council Houses. Also any applications for permission to carry out improvements or alterations to Council Houses.

The Processing of your data is:

- Because we have a legal obligation to do so.
- Because necessary for the performance of this task to do so.

2. How Information about you is used.

The information that you provide will be processed according to the General Data Protection Regulations 2016 and the Landlord & Tenant Act 1985 and The Construction (Design and Management) Regulations 2015

We have a duty to protect the public funds we administer and may use the information provided by to cross check the information with other departments of Pembrokeshire County Council.

We will make any disclosures required by law and we may also share this information with other bodies responsible for detecting/preventing fraud or auditing/administering public funds to ensure money is targeted and spent in the most appropriate and cost effective way. In order to achieve this, information may be shared with other internal departments within Pembrokeshire County Council and with the Auditor General for Wales.

We will not make any disclosures to third parties for marketing purposes. However, we will share information with contractors in order that they can contact you to carry out repair and maintenance tasks.

Your data will be secure and confidential at all times and we will only collect the personal information that is required to contact you about repairs and maintenance or assess your applications to carry out improvements/alterations to Council Houses.

3. How long do we keep hold of your information?

We will retain the information provided to us for repairs and maintenance requests for 5 years, applications for improvements or alterations will be retained until 5 years after tenancy expiry and your information will be securely disposed of once it is no longer required.

4. Access to my personal information?

You can find out if we hold any personal information by making a subject access request under the General Data Protection Act Regulations 2016. To make a request for any personal information we may hold you need to put your request in writing addressing it to:

5. Your Rights.

Under the General Data Protection Regulations 2016, you have rights as an individual which you can exercise in relation to the information we hold about you:

- The right of **access** you are entitled to request access to and a copy of, information we hold about you.
- The right to **rectification** you have the right to ask to have your information corrected.
- The right to restrict processing may apply you may request that we stop
 processing your personal data however, this may delay or prevent us delivering a
 service to you. We will seek to comply with your request but may be required to hold
 or process information to comply with our legal duties.
- The right to **object** this is not an absolute right and will depend on the reason for processing your personal information.
- The right to not be subject to automated decision-making and profiling.

6. Complaints or Queries.

Pembrokeshire County Council endeavours to meet the highest standards when collecting and using personal information. For this reason, we take any complaints we receive about this seriously. We encourage people to bring to our attention if they believe that our collection or use of information is unfair, misleading or inappropriate.
