Cynllun Datblygu Lleol 2 – Cofrestr Safleoedd Ymgeisiol Ychwanegol

Cyhoeddodd Cyngor Sir Penfro eilfed alwad am Safleoedd Ymgeisiol rhwng 17 Rhagfyr 2018 ac 4 Chwefror 2019. Safleoedd Ymgeisiol yw safleoedd a awgrymwyd gan y cyhoedd i'w cynnwys yn y Cynllun Datblygu Lleol. Derbyniodd yr Awdurdod 55 o Safleoedd Ymgeisiol Ychwanegol i'w hystyried. Cyhoeddir yr holl safleoedd fel mapiau o fewn y ddogfen hon (Cofrestr Safleoedd Ymgeisiol Ychwanegol).

Asesiad cychwynnol

Mae'r holl Safleoedd Ymgeisiol wedi bod yn destun prawf cydnawsedd cychwynnol i adnabod safleoedd sy'n cydymffurfio â'r [Strategaeth Ddewisol](#) drafft. Crëwyd system cod lliwiau sy'n nodi i ba raddau yr ystyrir bod safle a gynigiwyd yn cydymffurfio â'r Strategaeth Ddewisol:

Categori Coch = safleoedd preswyl na ystyrir eu bod yn gydnaws â'r Strategaeth Ddewisol. Mae'r rhain yn gynigion ar gyfer safleoedd mewn lleoliadau na ystyrir eu bod yn addas ar gyfer datblygiadau preswyl. Mae'n annhebygol y caiff y safleoedd hyn eu cynnwys yn y Cynllun Adnau.

Categori Oren = safleoedd preswyl sydd i ryw raddau'n cydymffurfio â'r strategaeth. Gallai'r rhain fod mewn lleoliadau y gofynnir am lefelau twf isel yn unig (ac felly mae'n bosibl mai rhan o safle yn unig fyddai'n cael ei hystyried), neu mewn lleoliadau nad ydynt yn union wrth ymyl ffin anheddiad. Gallai'r safleoedd hyn gael eu cynnwys yn rhannol yn y Cynllun Adnau, ond mae'n llai tebygol y byddant yn cael eu cynnwys na safleoedd Gwyrdd.

Local Development Plan 2 – Additional Candidate Sites Register

Background

Pembrokeshire County Council issued a 2nd call for Candidate Sites between 17th December 2018 and the 4th February 2019. Candidate Sites are sites suggested by the public for inclusion in the LDP. 55 Additional Candidate Sites were received by the Authority for consideration. All sites are published as maps within this document (the Additional Candidate Sites' Register).

Initial assessment

All Candidate Sites have been subjected to an initial compatibility test to identify sites that are compliant with the draft [Preferred Strategy](#). A colour coding system has been created which indicates the extent to which a site proposed is considered to comply with the Preferred Strategy:

Red Category = residential sites that are not considered compatible with the Preferred Strategy. These are proposals for sites in locations which are not considered suitable for residential development. These sites are unlikely to be included in the Deposit Plan.

Amber Category = residential sites which to some extent comply with the strategy. These may be in locations where only very low levels of growth are sought (and therefore potentially only a part of a site might be considered), or may be in locations not immediately adjoining a settlement boundary. These sites could be included in part in the Deposit Plan, but it is less likely that they will be included than Green sites.

Categori Gwyrdd = safleoedd preswyl sy'n gydnaws â'r Strategaeth Ddewisol. Mae'r safleoedd hyn mewn lleoliadau y gofynnir am ddatblygiadau preswyl i gefnogi Strategaeth y Cynllun Datblygu Lleol. Gallai safleoedd yn y lleoliadau hyn eu cynnwys yn y Cynllun Adnau, ond nid oes dim sicrwydd y bydd hynny'n digwydd. Bydd hyn yn dibynnu ar faint o dai sydd eu hangen a mwy o asesiadau manylach.

Categori Llwyd = I ddechrau, mae'r holl safleoedd amhreswyl wedi'u rhoi mewn categori (lliw llwyd), gan y bydd angen asesiad manwl ar y cynigion hyn, a hynny'n benodol i'r dystiolaeth sy'n gysylltiedig â'r defnydd a nodwyd; bydd hynny'n digwydd yn 2019.

Categori Llwyd gyda chroeslinellau lliw = Safleoedd defnydd cymysg gydag elfen breswyl. Mae'r croeslinellau yn dynodi'r categori o ran defnydd preswyl (gweler Coch, Oren a Gwyrdd uchod).

Categori melyn = safleoedd lle cynigiwyd nifer o ddefnyddiau anghyson. Bydd y tabl cyfatebol (gweler rhif unigol y Safle Ymgeisiol) yn dangos y categori i bob cynnig (e.e. coch, oren, gwyrdd neu lwyd).

Mae Ffiniau Aneddiadau cyfredol y Cynllun Datblygu Lleol 1 wedi'u cynnwys ar y mapiau er gwybodaeth yn unig. Mae ffiniau coch yn dynodi Pentrefi Gwasanaeth, Canolfannau Gwasanaeth a Threfi. Caiff y ffiniau hyn eu hadolygu fel rhan o ddatblygiad Cynllun Adnau'r Cynllun Datblygu Lleol.

Green Category = residential sites that are compatible with the Preferred Strategy. These sites are in locations where residential development will be sought to support the LDP Strategy. Sites in these locations could be included in the Deposit Plan, but there is no guarantee that this will happen. This will depend on the number of houses required and further more detailed assessments.

Grey Category = Initially all non-residential sites have been placed into a category (coloured grey), as these submissions will require detailed assessment, specific to the evidence relating to the use identified, which will take place in 2019.

Grey category with coloured hatching = Mixed use sites with a residential element. The hatching indicates the residential use categorisation (see Red, Amber and Green above).

Yellow category = sites where a number of conflicting uses have been proposed. The corresponding table (see individual Candidate Site number) will show the category for each submission (e.g. red, amber, green or grey).

The current LDP 1 Settlement boundaries have been included on the maps for information only. Red boundaries indicate Service Villages, Service Centres and Towns. Blue boundaries indicate Local Villages. These boundaries will be reviewed as part of the development of the LDP Deposit Plan.

Noder: Mae'r categorïau uchod ond yn dynodi sut mae safleoedd a gynigir ar gyfer defnydd preswyl neu gydag elfen o ddefnydd preswyl yn perfformio yn erbyn y Strategaeth Ddewisol a chyfyngiadau cychwynnol (perygl llifogydd a dynodiadau natur). **Nid ydynt mewn unrhyw fodd yn gwarantu y caiff safle ei gynnwys yng Nghynllun Adnau'r Cynllun Datblygu Lleol.** Bydd angen asesiadau pellach cyn y cam Adneuo mewn perthynas â chyfyngiadau eraill gan gynnwys Priffyrdd, ecoleg, tirwedd ac ymarferoldeb. Caiff y cyfyngiadau hyn eu hasesu yn ôl y dull a nodir ym [Methodoleg Safleoedd Ymgeisiol](#). Mater allweddol arall fydd lefel cyffredinol y tai sydd eu hangen mewn lleoliad, ac a oes eisoes safleoedd gyda chaniatâd cynllunio yn yr ardal honno a allai helpu i ateb yr angen hwnnw. Mae'n bosibl hefyd y gall adborth o'r ymgynghoriad ar y Strategaeth Ddewisol effeithio ar y penderfyniad i gynnwys neu beidio â chynnwys Safle Ymgeisiol yn y Cynllun Adnau.

Isod, ceir manylion o'r rhesymau amrywiol dros gategoreiddio safleoedd yn ôl y codau lliw gwahanol a nifer y safleoedd ymhob categori.

Note: The categories above only indicate how sites proposed for residential use or with an element of residential use perform against the Preferred Strategy and initial constraints (flood risk and nature designations). **They in no way guarantee that a site will be included in the LDP Deposit Plan.** Further assessments will be required prior to the Deposit stage in relation to other constraints including Highways, ecology, landscape and deliverability. These constraints will be assessed in the manner set out in the [Candidate Site methodology](#). A critical issue will also be the overall level of housing required in a location and whether or not there are already sites with planning permission in that area that could help to meet that need. Consultation feedback on the Preferred Strategy may also impact on whether or not a Candidate Site is ultimately included in the Deposit Plan.

Details of the various reasons sites have been categorised into the different colour codes and the numbers in each category are set out below.
