

Fair Processing Notice – (Sheltered Housing)

1. Why do we collect and keep your personal information?

We collect and use your personal information so that we can ensure that you are safe and happy within your home and comply with the necessary legislation.

The Processing of your data is:

- Because you have given your consent to do so.
- Because it is necessary for a contract to do so.
- Because we have a legal obligation to do so.
- Because it is necessary for the performance of this task to do so.

The information is required as part of the terms and conditions of the Supporting People Grant, to comply with the Landlord & Tenant act 1985, to comply with the Housing Act 2014 and to comply with the Social Services & Well Being Act 2016.

2. How Information about you is used.

The information that you provide will be processed according to the General Data Protection Regulations 2016.

We have a duty to protect the public funds we administer and may use the information provided by you on this form as well as any data matching techniques to detect and prevent fraud. We will cross check the information with other sections of Pembrokeshire County Council to ensure that a single customer record is held for you wherever possible. The data matching process is a proven way of helping to ensure that the records we hold for you are up to date and accurate

We will also make any disclosures required by law and we may also share this information with other bodies responsible for detecting/preventing fraud or auditing/administering public funds to ensure money is targeted and spent in the most appropriate and cost effective way. In order to achieve this, information may be shared with other internal departments within Pembrokeshire County Council and the Auditor General for Wales.

We will not make any disclosures to third parties for marketing purposes

Your data will be secure and confidential at all times and we will only collect the personal information that is required to access council services.

3. How long do we keep hold of your information?

We will only hold the information provided to us for as long as is required by law and to provide you with the necessary services. Data will be held in accordance with our retention schedules and will be securely disposed of once it is no longer required.

4. Access to my personal information?

You can find out if we hold any personal information by making a subject access request under the General Data Protection Act Regulations 2016. To make a request for any personal information we may hold you need to put your request in writing addressing it to:

5. Your Rights.

Under the General Data Protection Regulations 2016, you have rights as an individual which you can exercise in relation to the information we hold about you:

- The right of **access** – you are entitled to request access to and a copy of, information we hold about you
- The right to **rectification** – you have the right to ask to have your information corrected.
- The right to **restrict** processing may apply – you may request that we stop processing your personal data however, this may delay or prevent us delivering a service to you. We will seek to comply with your request but may be required to hold or process information to comply with our legal duties.
- The right to **object** – this is not an absolute right and will depend on the reason for processing your personal information.
- The right to **data portability**-this is not an absolute right (only applies when processing is based on consent, contract)
- The right to **not be subject to automated decision-making and profiling** (unless processing is based on consent, legal obligation, protecting vital interests, public task or legitimate interests and must satisfy an additional 3 criteria)

6. Complaints or Queries.

Pembrokeshire County Council endeavours to meet the highest standards when collecting and using personal information. For this reason, we take any complaints we receive about this seriously. We encourage people to bring to our attention if they believe that our collection or use of information is unfair, misleading or inappropriate.
