PRESELI PEMBROKESHIRE CONSTITUENCY

An election is to be held for a Constituency Member to serve in Senedd Cymru for the said Constituency.

Nomination papers may be delivered to the **Constituency Returning Officer at the Council Chamber, County Hall, Haverfordwest, Pembrokeshire, SA61 1TP** between the hours of **9.00am and 5.00pm** on any working day after the date of this notice but not later than **4pm on Thursday, 8 April, 2021**. Consent to nomination forms may be delivered by email to sian.waters@pembrokeshire.gov.uk.

Due to the present Coronavirus situation it is requested that prospective Candidates make an appointment, for the formal submission of their nomination papers, with the Constituency Returning Officer.

Nomination papers may be obtained from **Electoral Services Office, Unit 23, Thornton Industrial Trading Estate, Milford Haven, Pembrokeshire, SA73 2RR (Tel: 01437 775714)** at the times mentioned above.

The deposit for each candidate (£500.00) can be paid by cash or bankers draft (banks operating in the UK only) and with my prior permission by electronic payment, credit or debit card (subject to transaction fees).

If the election is contested, the poll will take place on **Thursday, 6 May, 2021**.

Applications to be included in the register of electors to be used at this election **must** reach the **Electoral Registration Officer, Unit 23, Thornton Industrial Trading Estate, Milford Haven, SA73 2RR** by **Monday, 19 April, 2021**.

Electors and their proxies should take note that all applications, amendments or cancellations for new and existing postal votes **must** reach the **Electoral Registration Officer, Unit 23, Thornton Industrial Trading Estate, Milford Haven, SA73 2RR**, by **5.00pm on Tuesday, 20 April, 2021**. This includes electors or their proxies who wish to make alterations to their existing arrangements on a permanent basis.

Applications to appoint a proxy **must** reach the **Electoral Registration Officer, Unit 23, Thornton Industrial Trading Estate, Milford Haven, Pembrokeshire, SA73 2RR**, by **5.00pm on Tuesday, 27 April, 2021**.

Applications to vote by emergency proxy at this election on the grounds of disability, for work/service reasons or the need to comply with an enactment or guidance from Welsh Ministers relating to coronavirus **must** reach the **Electoral Registration Officer, Unit 23, Thornton Industrial Trading Estate, Milford Haven, SA73 2RR** by **5pm on Thursday 6 May 2021**. The disability must have occurred after **5pm on Tuesday 27 April 2021**. To apply on the grounds of work/service or coronavirus, the person must have become aware that they cannot go to the polling station in person after **5pm on Tuesday 27 April 2021**.
